1. Purpose

The Group Chief Executive Officer has overall responsibility for communication with analysts, brokers, the media and other significant stakeholders.

The Group Company Secretary has overall responsibility for communication with the Australian Securities Exchange ("ASX"), the Securities and Exchange Commission ("SEC"), the New York Stock Exchange ("NYSE"), other regulatory bodies and all shareholders.

2. Releases etc

All material releases made by Sims MM to the ASX, SEC and/or NYSE are posted on Sims MM's website at www.SimsMM.com as soon as practicable following disclosure. All releases to the ASX, SEC and/or NYSE of a routine or minor nature may be accessed via Sims MM's website to the ASX's website.

All Sims MM's material releases, and annual reports, for the last three years, are available on Sims MM's website. The website also includes a feedback mechanism.

When analysts are formally briefed on aspects of Sims MM's operations, presentations containing material new information will be released to the ASX (and, if necessary, the SEC and/or NYSE) and posted on Sims MM's website.

The full text of a notice of shareholders' meeting and any explanatory material will be posted on Sims MM's website as soon as practicable after it is lodged with the ASX.

Contact details for executive directors and senior managers of Sims MM may be found on Sims MM's website.

Shareholders, unless they have notified Sims MM to the contrary, do not receive a copy of Sims MM's annual report. Holders of American Depositary Shares will normally be able to inspect copies of Sims MM's annual reports at the corporate trust offices of the Bank of New York (which acts as the depositary in respect of Sims MM American Depositary Shares).

3. Electronic communication

Broadcast Information

Shareholders may receive notification about Sims MM's announcements, annual and periodic reports and other Sims MM information by email. By registering for this service, shareholders can keep up to date with significant announcements as they happen.

Examples of the communications that may be broadcast include:

- general company announcements
- Chairperson's Address
- Notices of Meetings
- Annual / Half Yearly / Quarterly Reports

Shareholders may register by visiting Sims MM's share register at www.computershare.com and following these steps:

- Click on **Investors**
- Click on **Register your Email**
- Next, select **Sims MM** from the drop down list and click on **Submit**
- Then enter your personal security information: Holder Identification Number (HIN) or Security Reference Number (SRN); Family or Company Name and Postcode, and click on **Submit**.

After you have entered your email address and selected which publications you wish to receive, an email will be sent to you for confirmation purposes.

When you receive it, simply click **Reply** to confirm your details, and then **Send**.
